2. To give advice, assistance, shelter, guidance and direction to persons under the age of 21 years who are involved in or exposed to the use of drugs, undesirable influences including cult influences and negative peer pressure or who are destitute or runaways from homes and institutions.

- a) That, should the services of a fund-raiser be made use of for the collection of contributions, the expenses (remuneration and/or co-mission included) may not exceed 40% of the total proceeds of the collection.

Objects (continued)

3. To work with and assist law enforcement agencies including the South African Police, welfare, institutions correctional and educational facilities, institutions in the private sector, churches and religious organisations in removing, rehabilitating, placing, and generally assisting the persons referred to above.
4. To work actively towards combatting the criminal exploitation and abuse of such persons.
5. To educate or assist in the educating of the public in general in matters relating to drug abuse, juvenile prostitution and Aids by means of the dissemination of pamphlets and other literature, the holding of seminars and lectures and counselling.

Conditions (continued)

b) That the constitution be amended as follows:

- i) That clause 3 be amended to read as follows:
 "The Association will operate and collect contributions in the Magisterial districts of Alberton, Benoni, Boksburg, Brakpan, Germiston, Heidelberg, Johannesburg, Kempton Park, Krugersdorp, Nigel, Oberholzer, Potchefstroom, Randburg, Randfontein, Roodepoort, Rustenburg, Springs, Vanderbijlpark, Vereeniging, and Westonaria."
- ii) That the following clause be added to clause 5.3:
 "No members of the management shall "have an interest or benefit from any contract which the management concludes with any company."
